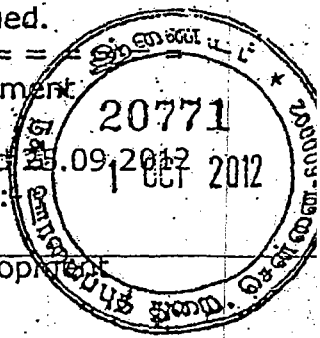

ORDER:-

In the Government Order first read above, a Committee was constituted under the Chairmanship of the Minister-in-Charge of Urban Development to undertake the work of preparing a broad development plan. On the southern side of the Chennai Metropolitan Development Authority limits preferably upto Mamallapuram area.

2. As decided in the meeting of the above committee, the Chennai Metropolitan Development Authority had sent a copy of interim report to Government, (Maraimalai Nagar - Thiruporur Area). The salient features of the above plan widening of Roads, MRTS Extension, new linkages of Roads, additional facilities to be provided by MTC, Intermediate Public Transport, Cycle ways, Pedestrian facilities, Lands layout, Social Structure, Heritage Conservation and Other Infrastructure amenities so as to develop the said area in a planned manner.

3. The Member Secretary, Chennai Metropolitan Development Authority had stated that once the High Level Committee headed by the Hon'ble Minister for Housing and Urban Development decides on the plan approach, design and concept, preliminary proposal and recommendations given in the Interim Report, details will be worked out and a draft final report will be prepared by the Chennai Metropolitan Development Authority.

4. The Government after careful consideration of the above report and after detailed deliberations, hereby approve the Interim Report submitted by the Chennai Metropolitan Development Authority and direct Chennai Metropolitan Development Authority under section 9(c)(vi) of the Tamil Nadu Town and Country Planning Act, 1971 to prepare a comprehensive draft development plan for the area comprising of 134 Villages, listed in the Annexure to this order.

5. The Member Secretary, Chennai Metropolitan Development Authority is directed to pursue action accordingly and submit the comprehensive draft development plan for the above mentioned area to the Government.
